Service Contract

By signing this document either physically or electronically, the customer agrees to the services and conditions outlined in this document.

I/we, the undersigned, recognize that I/we are hiring the services of Dan Hernandez, an ordained wedding specialist authorized to perform the rite of marriage in the State of California on _____, 2018, starting at _____ at _____ (venue) in _____, California.

• I/we, hereby hire Dan Hernandez to write and perform our wedding ceremony on the indicated date above.

• I/we, agree to pay \$100.00 of the agreed upon amount of \$250.00 at time of booking, as a non-refundable retainer.

• I/we, realize that payments on my final balance can be made at any time, however; I/we, also understand that the entire balance must be paid on the day of the wedding date prior to the commencement of the ceremony.

Upon signature and receipt of deposit, Dan Hernandez will reserve the time and date agreed upon, by signing the completed contract.

• I/we, further understand that the contracted fee above is based on the wedding ceremony ending one (1) hour from the stated start time in this contract. Should the wedding start late due to no fault of Dan Hernandez and not end within an hour of the contracted start time additional fees may be billed at \$50.00 per quarter hour.

• I/we, understand that Dan Hernandez will maintain the original copy of this contract and that I will receive a copy for my files.

PAYMENT TERMS

Check, cash, money order, or credit card will be accepted. Please make checks payable to: Dan Hernandez.

• I/we, understand that if my check is dishonored, Dan Hernandez is relieved of

all obligations set under this contract, unless I can immediately fix the situation with a cash payment plus a \$30.00 dishonored check fee.

• I/we, further understand that if my account is not paid in full prior to the wedding ceremony, Dan will not perform my wedding.

LEGALITY OF MARRIAGE

• I/we, also understand that it is my/our responsibility to possess a valid marriage license in the state where the wedding ceremony will take place and that the marriage license must be on the premises when the ceremony is performed.

• I/we, understand that failure to have these legal documents means that Dan Hernandez cannot legally perform the ceremony and is not obligated to do so, regardless of the inconvenience it may cause. I will consult with my local court/city clerk to find the exact requirements for my area.

• I/we, understand that in the event that either the bride or groom appears to be intoxicated and or otherwise under the influence of any type of controlled substance, or appears otherwise capable of making rational decisions of their own free will, Dan Hernandez will not conduct the ceremony of marriage and full payment will still remain due.

REFUND POLICY

• I/we, acknowledge that the amount of \$100.00 that was paid as a retainer is non-refundable. However, if Dan Hernandez cancels the wedding due to no fault of the bride and/or groom, we will receive a 100% refund on all payments made, unless he can provide a suitable substitute minister to officiate our wedding using our custom written ceremony.

• I/we, also understand that 75% of the work Dan Hernandez dedicates to our wedding is prior to the actual wedding date, such as the planning, consultations, custom writing of the ceremony script and other miscellaneous activities.

• I/we, understand that if we cancel our wedding after Dan Hernandez has completed their initial consultation with us (in person, via phone, video conference or via email), and if a draft of our wedding ceremony has already

been presented to us, we agree to pay 75% of the total amount of this contract. Both conditions must be met by Dan Hernandez to be entitled to this payment.

- I/we, agree that it is only fair for Dan Hernandez to be paid for the work completed.

- For cancellations within 14 days of the wedding date, there is no refund, and 100% of this contract will due to Dan Hernandez.

WEDDING DATE CHANGE IF THE WEDDING DATE IS POSTPONED OR CHANGED, THE FOLLOWING RULES WILL APPLY.

- If Dan Hernandez has the new date available; the date will simply be changed and reserved under the new date.

- However, if Dan Hernandez is already obligated on the new date, and is unable to officiate your wedding, then the initial security retainer of \$100.00 is forfeited and Dan Hernandez is relieved of all responsibilities set forth in this contract.

SUBSTITUTION OF OFFICIANT

- If Dan Hernandez is unable to attend due to an unforeseen emergency or illness, Dan Hernandez will make attempts to have a replacement Officiant made available for the wedding ceremony. The Substitution will be instructed in all matters pertaining to the duties of the ceremony and be giving a copy of the script. The substitute Officiant will be paid by Dan Hernandez. In the event any balance remains on the day of the ceremony, I/we will pay the remaining balance to the substitution.

Props, Microphone, Speaker, Music

- I/we, understand that should we decide to include any additions into our ceremony such as unity candle ceremony, hand-fasting ceremony, unity sand ceremony, unity painting ceremony ect. We will purchase separately and solely and have all items and or props available on the day of the ceremony.

- I/we, upon request will be provided a microphone and speaker for use of the ceremony at no additional cost by Dan Hernandez.

• I/we, upon request, Dan Hernandez may provide music for the ceremony which includes bridal party's entrance music, bride's entrance music and bride – groom exit music.

Keepsake Marriage certificate & video

• Every couple will be given a keepsake marriage certificate as a memento of their special day, signed by the presiding Officiant. I/we understand that this certificate is not valid or official proof of marriage and is merely a reminder keepsake.

• Upon request at an additional fee Dan Hernandez may provide an keepsake video of your ceremony the HD standard format video is available for \$50.00 unless otherwise stated by Dan Hernandez. Once processed Dan Hernandez will email you the finished produced video for your own use.

• Dan Hernandez now offers every couple a very special and unique keepsake video option in which the video is filmed and viewed in a one of a kind 360 degree video format. This option is available for a fee of \$75.00 once processed the final video will be placed on a secure and private YouTube link which may be shared and viewed by the couple; no special app or equipment is required. The video will also be emailed to the couple along with a 360 degree viewer app so that the couple may download and view the video.

• I/we, understand that video requests must be made prior to the wedding ceremony date.
